# Citation Guide: How do I cite correctly?

Writing a research paper does not mean reinventing the wheel. You may and should draw on knowledge and practice that others have already achieved in your field: Science is a cooperative venture! Traceability is crucial. This is the hallmark of 'good scientific practice,' and in addition, allows the readers of your work to investigate the same sources. It also enables the reader to judge whether you have drawn justifiable conclusions from them, and further develop their knowledge.

The findings of other authors, however, are as a rule protected by copyright. If you intend to base your work on these findings, you therefore must identify where and from whom they come from.<sup>2</sup>

The top priority in academic work is the clear separation of the work of other authors from your own. This guide, therefore, deals with the following questions:

- How do you distinguish thoughts, insights, and arguments in the text that are not your own?
- How do you identify your sources in your reference list?
- How do you link the citation in the text with the source in the reference list?
- What are the formal rules for citations?
- What tools are available to help with citing?

The University Library also offers courses on citation for students and researchers (see Chap. 5.6)

# 1. Why, when and what do I have to cite?

# 1.1 Why cite at all?

A key element of good scientific practice is making your results verifiable. One prerequisite for this is attributing work to its proper author. For this reason, you have to reference the author every time you mention their ideas or results in your scientific work.

There are two reasons why we cite:

- Many works are protected by copyright law.
- The rules of good scientific practice require you to identify others' ideas (regardless of whether they are protected by copyright law or not).

With this in mind, the TUM has published the "Code of Conduct for Safeguarding Good Academic Practice and Procedures in Cases of Academic Misconduct at Technische Universität München" (Technische Universität München, 2013).

#### 1.2When should I cite?

It is always recommended to cite when you ...

- 1. ... take information from external sources,
- 2. ... present previous research,
- 3. ... discuss the content of research, or




Figure 1: Overview of citation purposes. Adapted from von Kessel, E. (2016, p. 151). Items marked with \* have been changed or added.

- 4. ... establish a connection to your own research question (see Fig. 1).

Explanations and examples for the different citation options can be found in (Kessel, 2016, pp. 151-164).

According to the rules of good scientific practice, you must cite everything that you have taken from external sources both word for word and in terms of content.

#### General knowledge

Conversely, this also means:

You do not need to cite content that is available from many sources and is not new, controversial, or unusual. This particularly relates to **general knowledge** (the fall of the Berlin wall occurred on November 9, 1989, and the formula E = mc<sup>2</sup> was written by Einstein) and **basic knowledge in your area of expertise** (e.g. the laws of thermodynamics in physics).

There is, however, no clear boundary. As a rule of thumb, you can assume that knowledge that can be found in a textbook for the corresponding Bachelor's program, does not need to be cited. Nevertheless, you should consider that, depending on your target audience, the basic knowledge in your area of expertise might not be known to your reader and should, therefore, be cited.

It may also matter, whether you are writing a Bachelor's, Master's, or doctoral thesis. At Bachelor's level, it would be more likely to cite more general sources. If you are uncertain whether you have to cite, ask your supervisor. When in doubt: better cite than sorry.

#### Original & secondary citations

You should always cite the **original source** if it is possible. Citations of citations, so-called **secondary citations**, you should only use if you cannot access the original source without unreasonable difficulty. This particularly applies to review articles. More on secondary citations see Chapter 2.1.3

#### Citability

Sources should meet the **required standards of scientific work**. Depending on the purpose of a citation you should choose the source accordingly. It might be appropriate to cite data sets from a degree thesis if these are correctly cited; especially if the author supervised it themselves and can therefore guarantee its quality.

In principle, you should try to find well-recognized sources. This is especially true for articles from peer-reviewed journals and conference proceedings. Journals and proceedings which can be found in big databases like Scopus or Web of Science, you can assume to meet the quality requirements for good scientific sources. This is also true for books that have been published by established publishing houses.

Sources that have not undergone quality assurance procedures such as a peer review process, may be cited within certain limits (e.g. citation of a product data-sheet or the like).

In a scientific context, citing **Wikipedia** is viewed with skepticism. Reference lists are often incomplete and the origin of the information given is unknown. Even if Wikipedia now places increasing emphasis on references, it is always preferable to access and cite the original



source. Moreover, Wikipedia articles can be manipulated easily and the author is often not identifiable.

# 1.3 Copyright law and good scientific practice

Copyright law protects the author of a work from unauthorized use of their intellectual property. This especially includes copying, editing, and distributing the work to protect the author from financial loss.

But according to the German constitution (Art.14 Abs. 2) property should be used to the benefit of the community. Due to this, the rights of the author are in certain respects limited. These limiting regulations are called "statutory exceptions" (In German: "Schrankenregelungen").

The most important limiting rule in this regard is the right to citation or "Zitatrecht" (§51 UrhG).

"Zulässig ist die Vervielfältigung, Verbreitung und öffentliche Wiedergabe eines veröffentlichten Werkes zum Zweck des Zitats, sofern die Nutzung in ihrem Umfang durch den besonderen Zweck gerechtfertigt ist. Zulässig ist dies insbesondere, wenn

- einzelne Werke nach der Veröffentlichung in ein selbständiges wissenschaftliches Werk zur Erläuterung des Inhalts aufgenommen werden [...]<sup>43</sup>
- Stellen eines Werkes nach der Veröffentlichung in einem selbständigen Sprachwerk angeführt werden,
- einzelne Stellen eines erschienenen Werkes der Musik in einem selbständigen Werk der Musik angeführt werden."

#### When does the right to citation (Zitatrecht) apply?

- The citations must have a purpose. This means, there has to be a content-related connection between your work and the cited work. To illustrate this connection a substantive discussion of the cited work must be given in your work. Without this discussion, the citation cannot be used.
- 2. Consequently, a citation for mere illustration, ornament, or workload reduction is not permitted.
- 3. Always cite as much as necessary but as little as possible.
- 4. A quotation may not be altered.
- 5. The quoted text must be identified.
- 6. You must give a full reference to the source.

You can easily remember the requirements for the right to cite using the **PEMUC** scheme:

Purpose of citation

**E**xplanation

**M**inimum

Unchanged

Credit

The "Credit" part contains both the identification of the cited material as well as giving the full reference.

Here is a handy checklist you can use to find out whether you are complying with copyright law: "May I cite this publication?"

#### What is protected by copyright law? - §2 UrhG

- "(1) Copyright law protects works of literature, science, and art. This includes
  - 1. language works incl. written works, speeches, and computer programs,
  - 2. musical works,
  - 3. theatrical works including dance,
  - 4. works of fine art including works of architecture and applied art as well as drafts of such works.
  - 5. photographic works including works created similarly to photographic works,
  - 6. cinematographic works including works created similarly to cinematographic works,
  - 7. illustrations of a scientific or technical nature, such as drawings, plans, maps, sketches, tables, and three-dimensional representations.
- (2) Works as defined by this law are only human intellectual creations".

For a work to be protected by copyright law it has to have a perceptible form. Copyright law applies only to direct citations, not to the idea itself.

#### Term of copyright protection

The copyright covers photographic works until 70 years after the death of the copyright holder (§ 64 German Copyright Act); for simple photographs for 50 years after the appearance of the photograph (§ 72 para. 3 of the Copyright Act). The period of protection expires at the end of the 70th year after the author's death or at the end of the year 50 years after the snapshot's appearance. After this time, the picture is copyright-free. Due to the rules of good scientific practice, you still have to cite it. But now you are permitted to use the image beyond the purpose of citation (substantiating an argument, used in an academic work).

Note that the copyright can be passed on to the author's heirs or to a foundation especially founded for the purpose to represent the author's rights after his death.

Copyright allows you to quote in academic works. However, do not draw the reverse conclusion from this that you do not need to cite the source of copyright-free content (e.g. because the author has been dead for more than 70 years or the content has been published under a



corresponding license). According to the rules of good scientific practice, you must cite all content taken from other sources, regardless of whether it is protected by copyright or already in the public domain.

#### **Good scientific practice**

Copyright law has to be distinguished from the rules of good scientific practice, which should ensure a high quality of scientific work (DFG, 2019; Technische Universität München, 2013). Briefly summarized, good scientific practice involves:

- Documenting scientific findings comprehensibly, traceably, and accessibly.
- Consistently testing your findings and making them accessible for review and testing by others.
- Maintaining integrity concerning contributions by partners, competitors, and predecessors.

It is for these reasons that not only do direct quotations have to be cited but paraphrased ideas as well.

More specifically this means ...

- ... you take the current state of research into account when planning your work. This requires a careful review of the previously published works.
- ... you do not pretend other people's ideas are your own.
- ... you cite other researchers' findings and ideas.
- ... you do not make false statements or fabricate data.
- ... you objectively include all positions and findings and also publish results that challenge your hypothesis.
- ... you describe methods and outcomes to make your results verifiable.
- ... you use scientifically sound and comprehensible methods.
- ... you consider what the wider and ethical consequences of your research could be.
- ... you secure long-term access to your research results (at least ten years).
- ... you publish only new scholarly results.
- ... you do not publish your results in fragments to create the appearance of multiple publications.
- ... you acknowledge your responsibility if you are a co-author.
- ... you do not sabotage the research of others.
- ... you do not make false accusations.
- ... that supervisors act as role models and live by the rules of good scientific practice.
- ... that young researchers are appropriately supervised.
- ... that originality and quality take precedence over quantity.
- ... that academic misconduct is openly discussed. (DFG, 2019)

# 1.4 Plagiarism and how to avoid it

Plagiarism is when you present someone else's work as your own.

To present someone else's intellectual property as your own disagrees with the central rules of good scientific practice. If citations are not marked as such, the reader is led to believe that it is an academic work attributable to the author. Plagiarism is not about specific citation



styles or oversights in citation, but about concealing external sources. It is where other authors' texts are included verbatim, paraphrased, or translated, but not marked as citations. Plagiarism is a serious offense and may lead to the disqualification of an academic title, or even criminal prosecution.

At TUM there is an ombudspersons' office for good scientific practice, which among other things, deals with cases of plagiarism. The ombudspersons' office is responsible for receiving and investigating complaints, settling them, or where appropriate taking action which might include involving the TUM justice department.<sup>4</sup>

There are different forms of plagiarism. The main types are<sup>5</sup>.

- Complete plagiarism / copy & paste plagiarism: to use another author's text unchanged, without citation, and pretend it is one's own work (*VroniPlag Wiki Plagiatskategorien*, 2014; Weber-Wulff, 2004a).
- Clause splicing / Shake & paste plagiarism: combining fragments of different texts or sentences to form a new text without citation, thus presenting it as one's own line of thought (Weber-Wulff, 2004a).
- 3. **Idea plagiarism / obfuscation**: presenting another author's ideas in your own words without citing the source (*VroniPlag Wiki Plagiatskategorien*, 2014).
- 4. **Translation plagiarism**: Translating an original text from another language without citing the source (*VroniPlag Wiki Plagiatskategorien*, 2014; Weber-Wulff, 2004a).
- 5. **Bibliography balloon**: Listing references in the reference list that have not been cited in the text (Projekt Refairenz, 2017).
- 6. **Bibliography amnesia**: giving in-text citations without listing the complete reference in the reference list (Projekt Refairenz, 2017).
- 7. **Pawn sacrifice**: only part of the cited content is marked as a citation (*VroniPlag Wiki Plagiatskategorien*, 2014).

<u>Note</u>: Even if an author (e.g. a classmate) willingly consents to the uncited use of her text, you are nevertheless guilty of plagiarism, unless you cite the contribution! (Neville, 2010, p. 30)

Plagiarism arises not only through failure to cite, but also then when you do reference another's work, but do not make it clear to the reader how far the citation extends. This happens, for example, when a summary gives the impression that it is the author's own work when it is not.

#### What can you do to avoid coming under suspicion?

Collect and organize your sources carefully from the start. Highlight important points in your reading and excerpting, so that afterward you still know what you have read and where it comes from. Even in all your written drafts, you should mark the sources and quotations. The easiest way to organize knowledge and manage references is to use an appropriate system from the outset. This can be a simple checklist, but the more usual working method these days is to rely on dedicated software, such as the reference management programs Citavi or EndNote. More on reference management programs in Chapter 5.

Proper time management is another way to avoid unintentional plagiarism caused by time pressure. Make a list of all the tasks arising during your work and how much time you would need for each task. Here you find a checklist to help you with that: <u>"From empty sheet to finished thesis - Avoiding plagiarism with good time management"</u> (German).

If there are tasks you are uncomfortable with, try to get help. The TUM offers a broad variety of courses and services to support you with research, academic writing, or excerpting (see p. 2 of the checklist).

To build a solid basis for your citation practice, try to develop an inner citation compass using the following four principles:

- Principle 1: Usability May I cite this source?
   Before citing a source, you should always check whether you are permitted to cite it.
- Principle 2: Authorship Which ideas are mine, and which belong to someone else?
   Always make sure to indicate the beginning and end of another author's idea, as well as the author.
- 3. Principle 3: Retrievability Where does my information come from? Can my reader find my sources?
  - Always make sure your reader has all the relevant information needed to find and identify a source.
- 4. Principle 4: Consistency Did I apply my chosen citation style consistently? Choose one citation style and stick to it!

Make sure you always know ...

- 1. what the purpose of your citation is
- 2. whether you meet all requirements to cite a copyright-protected source and
- 3. that your reader can find the original source.

Here are the four principles for printing: <u>Citation in a nutshell – the four citation principles</u>.



# 2. How to cite in the text

#### 2.1 How to cite?

You have two possibilities to cite foreign results and thoughts in your text, either directly, i.e. verbatim, or indirectly, i.e. in your own words. When you rephrase a statement, it is called paraphrasing.

# 2.1.1 Direct quotations

The sentence mentioned earlier from Umberto Eco, "Ein Buch zitieren, aus dem man einen Satz übernommen hat, heißt Schulden zahlen" is used exactly as in the original. It is quoted directly, so it is quoted *verbatim*. Direct quotations are used when the exact wording is important. They are especially common in the humanities when dealing with a source. In the natural sciences, it is mostly about the content of the statement, not how it was phrased. Therefore, direct quotations are very rare in the natural sciences and should only be used when the phrasing is crucial. This can be the case, for example, with definitions, standards, or legal texts. Otherwise, you should use direct quotations extremely sparingly. Please note the following:

Quotations have to be quoted **exactly** (that means letter for letter including old spelling or spelling mistakes; how to mark those see below).

**Quotation marks** indicate a direct quote; longer quotations (three lines or more) are indicated by the formatting. You can indent them, use italics, or set them in a smaller font. You then do not need quotation marks.

**Misspellings:** Accept misspellings or special formatting as in the original source, such as italics or bold; where there is a spelling error in the original source, identify it with the designation [sic]. "Sic" is Latin for "just like that." It shows your reader that you are aware of the error, but that it really did occur in the original source. A detached exclamation mark in square brackets [!] is also sometimes used for this purpose. If you work a lot with historical sources, it is advisable to dispense with this indication for old spelling.

**Omissions**: If you omit a part of the verbatim quote, you must indicate this with [...]. Bailey (2011, p. 66) proposes only three dots ... for omissions, but three dots in round brackets are also common (...). Base your style on the practices in your particular field and the selected citation style.

**Additions**: Your own additions or grammatical adjustments to the quoted sentence must be identified, e.g. [Author's note/Editor's note/ed. Note], or for grammatical adjustments: Eco notes that "to cite a book [...] means to have paid one's debts [off]" (Eco, 2010, p. 213).

**Emphases**: Emphases, which are part of the original source, are maintained and marked, e.g. [emphasis by the author / emphasis in original / emphasis + author's initials]. As long as it does not change the meaning, emphases may be omitted if marked e.g. by (Müller 2000, p. 33; without emphasis). Emphases added by you have to be marked, e.g. [my emphasis].

**Original language**: Always quote in the original language, and insert a translation for minority languages in a footnote. In this case, note who translated the quote (if you cite a translation, name the source if you translated it yourself add (translation by the author). Please note, however, that paraphrases should always be in the same language as your own work.

**Quotation within a quotation**: If the verbatim quoted section already contains a quote, indicate the outer quotation in single quotation marks. Depending on the language of your work it may also be common to use single quotation marks around the outer quotation and double quotation marks around the inner quotation.

**Cite source**: It varies depending on the citation style (see chapter 2.2) but it is always given directly with the quotation.

# 2.1.2 Indirect quotations / Paraphrasing

To incorporate opinions or findings of other authors in your text, you do not need to quote verbatim. You can also summarize their views or findings in your own words. This procedure does not, however, relieve you of your obligation to cite the author, and to **pay your debt!** You will by now be familiar with the phrase at the end of the last sentence. It refers back to Umberto Eco (2010, p. 213). This way of referring to another author is known as an indirect quotation (or: paraphrasing). In STM subjects (STM = science, technology, and medicine), as well as the economic and social sciences, this is common practice.

You should consider the following:

**Use your own words:** Summarize what you have read in your own words; this automatically means that you always cite indirectly in the same language as your own work.

**Introductory phrases:** If the formatting and source citation do not by themselves make it sufficiently clear which content is your own and which you are indirectly citations, it makes sense to use an introductory phrase: As Eco (2010) points out, by citing a work, one pays the author back for the use of their idea.



#### Position of in-text citation:

1. **In introductory phrases**: You can indicate the source at the beginning of the sentence in an introductory phrase. In author-year styles, the author is then usually removed from the brackets of the source citation and placed in front of it. *Example: Müller (2004, p. 23) distinguishes between ...*.

This method is also useful if you cite a longer section or an entire chapter from the same source and do not want to cite the same source again after each sentence or paragraph. This may be the case if you have a study that is fundamental to your research and which you summarize in your paper to build on it. The prerequisite is that you truly cite from this source only.

Example: In the following three sections / chapter I summarize the results of Maier (2011).

It is also common to indicate the source at the end of the sentence. A distinction is made here between a reference within the sentence, which means before the full stop, and a reference that follows the sentence.

- At the end of the sentence before the full stop: A reference made before the full stop, which is still part of the sentence, refers only to the sentence in which it is mentioned.
- At the end of the sentence after the full stop: A reference after the sentence refers to the entire paragraph, or up to the last-mentioned reference in this paragraph.
- 4. **Refer to a previously cited source**: Sometimes you want to cite two or three consecutive sentences from one source. However, you are not citing a whole paragraph. In this case, you can indicate the source in the introductory phrase of the first sentence and refer back to this first sentence in the following sentences. *Example: Müller et al. (2018)* studied the behaviour of .... . He discovered that, ... . The assumption that, ... could not be confirmed. Instead, Müller et al. found that ... has an influence on ... .
- 5. Page numbers: In-text citations are usually given with a page number. In some disciplines, it is also common to omit the page number. When making your decision, always bear in mind that you want to make your argument as traceable as possible a page number helps your reader to check your arguments.

**Vgl.**: In German, in some subject areas and citation styles, it is common to insert vgl. before indirect quotations, e.g. (vgl. Eco 2010, p. 213). Cf. is not equivalent to the German vgl. although many dictionaries offer it as a translation. In English academic writing, indirect quotations should be cited directly (without cf. or see). **Cf.** or **see** provide further references to compare either similar or contrasting arguments or information.

**Multiple citation**: To add support or emphasis to an argument or to demonstrate that the literature is unanimous in this respect, it is possible to insert a multiple citation. The citation would look like this: (see for instance Author1, 2010, p.1; Author2, 2011, p.2; Author3, 2014,



p.5.). Depending on the subject area and selected citation style, the in-text attribution may be omitted: (Author1, 2010, p.1; Author2, 2013, p.2).

If you are unsure how to include indirect quotations in your text, you can find examples of wording grouped by the purpose of the citation in German in Kühtz (2016, pp. 73-106) and in English in Morley (2015).

# 2.1.3 Secondary citations

Before using a secondary citation, always try to obtain the original source, check the statement, and then quote the original source directly. As a rule of thumb, you could say that everything that can be procured via the Germany-wide interlibrary loan must be procured. Only if this is not possible, use secondary citations. If secondary citations are used too often without being checked, a kind of Chinese whispers syndrome can occur, in which the original content is further and further changed until it can no longer be recognized. If you cannot avoid using a secondary citation, you have three different options how to do it:

You provide both primary and secondary sources. In the text, the source is then cited e.g. like this: (Müller 2011, p. 50 cites Meier 2010, p. 100) or in number style [21 cites 5]. In the reference list, cite both sources individually. The in-text citation of the source shows that you have not read the primary source yourself.

However, opinions differ as to whether the original source, in this case, Meier 2010, should be listed in the reference list. On one hand, the reference list usually only lists sources that have been read and cited by the author, on the other hand, you make it easier for your reader to access the original source, which is the reader's actual destination.

The original source is only mentioned in a footnote. Only works that you have read and cited yourself are mentioned in the reference list. This would be the secondary source that you have read - in this case, Müller 2011. However, since Müller 2011 is not the author of the statement, you indicate the original source in a footnote, which then does not appear in the reference list.

The in-text citation could look like this: (Müller 2011, p. 50)<sup>2</sup> or [21]<sup>2</sup>.

In the footnote: (Müller 2011) / [21] cited [here you name the full reference of the original source].

The original source is mentioned in the text only. In the reference list, just works that you have read and cited yourself are given. In the text, you could then refer to the original source with a sentence like this: Müller (2011, p. 50) refers in his work to a text by Meier from 2010 with the title ..., which cannot be found.

# 2.2 Citation systems and citation styles

To enhance readability, one generally avoids writing the complete source one is acknowledging directly after the quote in the text. Rather, we use a kind of **placeholder** that links to the full reference in the reference list at the end of the work.

Depending on the citation system and the citation style, placeholders and full references look different. We differentiate between three different citation systems: author-year, number, and



footnote. Each of these citation systems has hundreds of different citation styles. The citation style defines exactly how the in-text citation and the full reference in the reference list should look like.

#### a. author-year system

In-text citation:

- with full name, e.g. Meyer (2011), (Meyer 2011), (Meyer 11) or
- the abbreviated name, e.g. (MEY 11) or [MEY11]

In the reference list:

- (Meyer 2011) Meyer, Michael: Title. Place: Publisher, 2011 or
- Meyer, Michael (2011): Title. Place: Publisher.

#### b. Number system

In-text citation:

• [5] or (5)

In the references:

• [5] Meyer, Michael: Title. Place: Publisher, 2011.

#### c. Citation key system

In-text citation:

[Mey11] or (Mey11)

In the references:

- [Mey11] Meyer, Michael: Title. Place: Publisher, 2011.
- (Mey11) Meyer, Michael: Title. Place: Publisher, 2011.

#### d. Footnote system

In-text citation:

e.g. quotation<sup>2</sup>

In the references:

• as a rule, on the first mention, the full reference appears at the bottom of the page:

- for all other entries of the same title, it is usually sufficient, depending on the citation style, to insert a short citation at the end of the page:
  - <sup>3</sup> Meyer 2011
- Particularly in European citation styles, if the same page in the same work has already been directly cited earlier, the Latin abbreviation *ibid*. (ibidem) may be used.
   While its use is declining, reference management programs will insert it, again depending on the citation style, automatically.

# 2.2.1 Citation styles

There is a large number of recognized citation styles. Academics and publishers develop and maintain these different styles. Therefore, almost every modern academic field, and almost every publisher and journal have their own rules for the correct formatting of citations.

#### Which citation style should I use?

- If you publish in a journal or a textbook, the citation style is determined by the requirements set by the editor or publisher.
- If you are a student writing your final paper, always ask your supervisor or the department which style to use.
- If there is **no set style**, see chapter 6 where you will find three established citation styles you can use. If there is a standard style for your field, use this. In addition, you have the option of citing according to DIN ISO 690 this citation standard is recognized throughout Germany.

Along with formatting rules for your references, the in-text citation also follows the particular citation style.

#### Some general information:

If a work is written **by three or more than three authors**, there is a special set of rules depending on the selected citation style. Bailey (2011) recommends that where there are three or more authors in an in-text citation, only the first be specified and all further author names be replaced with "et al." (Bailey, 2011, p. 69). For example: where a work is co-authored by Franz Müller, Joseph Mayer, and Sebastian Schmitt 2012, the in-text citation names only the first author and adds et. al. for all other authors. (Müller et al., 2012, p.5). In the reference list, all authors are listed. Incidentally, if you are using reference management software, the reference is automatically inserted according to the specifications of the selected citation style; you do not need to concern yourself further.

If you are referring to a **specific place in an article or book**, you should specify it as precisely as possible, i.e. insert page numbers or other numbering used in the article in your intext citation. The particular citation style governs how the page number is inserted in the citation. This often happens after a comma with "p.", e.g. (Meyer 2011, p. 3), (MEY 11, p. 3), [5, p. 3].

When you quote **an entire section from a book or article**, you should cite once at the beginning or end of the quotation, not after each sentence. Make it clear that your citation refers to the whole section, not only to the first or last sentence, e.g. "The following section summarizes the results from [9].

**If details are missing**, e.g. the author, the year, or the location of publication, you may point this out by using the following abbreviations. This shows that your work is not simply sloppy but that despite further research you could not identify the missing information.

- Author: o.V. (ohne Verfasser), N.N. (nomen nescio), or N.U. (name unknown)
- Year: o.J. (ohne Jahr), s.a. (sine annum), n.y. (no year) or n.d. (no date)
- Location: o.O. (ohne Ort), s.l. (sine locum) or n.p. (no place)

If there are no authors specified for a source, often the publishing institution or company takes the authors' place.

Examples of current citation styles (taken from the reference management software, Citavi, read more in chapter 6):




Figure 2: Citation styles APA 7th, IEEE Editorial and Chicago notes 16th

# 2.2.2 Citation in science, technology, and medicine (STM)

Academic achievements in the STM subjects are in most cases not dependent on their exact wording, but are theories, theorems, studies, experimental results, etc., and are usually cited indirectly. In-text citations are indicated with short citations (numbers or author-year system); footnotes are not usual.



Direct quotations are rare and should only be used when the precise formulation is important. It is not always customary to put these in quotation marks, e.g. if you "word-for-word" quote a formula or a mathematical theorem.

When citing, you can mention the author in the text or only in a short citation.

#### Examples:

From the study by Maier and Müller [7], it is known that...

Since the solutions to this equation are always limited [8, Theorem 1.7], it follows that...

As mentioned before you should always if you refer to a particular place in an article or book, specify them as accurately as possible, i.e. insert page numbers or a different numbering (as in the last example), which is used in the article in the short reference.

#### 2.2.3 Citation in the economic and social sciences

Indirect quotes are very common in economics and social sciences. It is important that you reformulate what you have read in your own words and not simply change a few words in the passage quoted.

Direct quotations are also common in economics and social sciences but should be used sparingly and only used when it is essential to reproduce the exact wording of a line of argument or an opinion. You can also mark longer direct quotations from your body text by formatting, for example, by indenting the quote (left or right) or using italics. You then do not need to use quotation marks. Be careful to reproduce the quotation exactly and identify omissions with an ellipsis (three dots) in square brackets.

To mark quotations in the text, two main systems are common in economics and social sciences: the short citation using the author-year system, and the footnote system.



# 3. How do I list different sources in the reference list? And what do I have to consider?

A list of references is always found at the end of a chapter or work and you must cite all literature that was used, whether directly quoted or indirectly.

The list must be prepared following uniform rules (in the selected citation style). The titles are either sorted alphabetically by the author's surname or numerically according to the order of their appearance in the text.

If you cite multiple publications by the same author within the same year these are marked by e.g. using lowercase letters: Example: Eco (2010a), Eco (2010b).

If a publication has no author or editor, you sort by the first significant word in the title.

Some journal publishers require items to be sorted in the order in which they were first mentioned in your work. This arrangement of the titles in the list of references is particularly popular for shorter publications or works in which very little literature is cited and is used only with the number system.

#### **Elements of a Source Citation**

Below you will find examples of how different document types are indicated in the reference list. Sometimes, however, a document type cannot be clearly determined, or the citation style used, does not offer a definition for this document type. It is therefore necessary that you find a solution yourself that comes as close as possible to the citation style.

In principle, every source citation must answer these four questions:

**Who** created the work? The author, artist, or, if no person is named, the publishing institution is indicated here.

**What** kind of work is it? Here you give the title and, in the case of rare document types, a description of the source in square brackets.

**When** was the work published? Here you give the year of publication, the date of the last update, or the posting date.

**Where**: Where was the work published or where can the reader find it? Here the type of information can be quite different. For books, the publisher and the place of publication are given; for journal articles, the name of the journal plus the year, volume, issue, and page number; for websites, you provide the URL; for materials that are only found in an archive, the name of the archive and, depending on the citation style, the archive shelfmark.

Unless otherwise indicated, the references for all the following examples are formatted according to the rules of the *Publication Manual of the American Psychological Association* 7<sup>th</sup> edition (American Psychological Association, 2020).

Depending on the type of publication, the complete list of references contains various elements. The specifications can be found in the respective style guides or publication manuals. Some citation styles prescribe that author names be written out in full while others require the



abbreviated (initialized) first names. Generally, it is easier for your reader to trace sources back when the author's name is given in full. In our examples, given the very wide adherence to the APA style, we have held to the requirement of the Publication Manual by the American Psychological Association, where first names are always abbreviated.

According to APA style guidelines, the author's name is always followed by a full stop. If the author is a person there is already a full stop due to the abbreviated first name. However, if the author is an institution the full stop is either added manually or automatically by your reference management program. There are never two full stops in a row.

#### **Electronic publications**

In general, the same requirements apply to electronic publications as their printed equivalents: author(s), title, journal title, issue number, volume number, and year of publication must be specified for articles from e-journals, just as for printed journal articles. It makes sense, however, to **provide extra information where available** (e.g. the DOI). Your readers will be able to trace the source more easily. At present, it is recommended to give the DOI as a clickable link "<a href="http://dx.doi.org/10.1007/978-3-658-02511-3">http://dx.doi.org/10.1007/978-3-658-02511-3</a>" instead of "doi:10.1007/978-3-658-02511-3" (Pampel, 23.09.2016).

# 3.1 Blog posts

Depending on the reference management program you use the representation of the source may differ. Some citation styles indicate the type of source after the title e.g. "Online" or "Blog".

# 3.6 Images

# 3.6.1 Images are protected by copyright law!

Under German law, each image (= photographic work, and photographs) enjoys copyright protection from its inception.

A copyright symbol, sometimes denoted with (©), is not necessary and does not influence the copyright. Each of the above-described works enjoys copyright protection from the moment it comes into existence without having to be applied for. Copyright protection includes the author's personal rights (e.g. the right to be named as the author and not to be misrepresented) as well as the so-called exploitation rights (e.g. duplication, public broadcasting, or display).

The Copyright Act distinguishes between:

- photographic works (= photograph with a certain degree of creativity, according to article § 2 para. 1 no. 5 of the Copyright Act),
- photographs (= photograph, any arbitrary snapshot, § 72 of the Copyright Act), and
- other images e.g. technical drawings.

#### Other images

Other images (e.g. technical drawings) are only protected by copyright law if they meet the necessary level of creativity; this means they can be distinguished from program-generated images through the author's personal creative contribution.

#### Term of copyright protection

The copyright covers photographic works until 70 years after the death of the copyright holder (§ 64 German Copyright Act); for simple photographs for 50 years after the appearance of the photograph (§ 72 para. 3 of the Copyright Act). The period of protection expires at the end of the 70th year after the author's death or at the end of the year, 50 years after the snapshot's appearance. After this time, the picture is copyright-free. Due to the rules of good scientific practice, you still have to cite it. But now you are permitted to use the image beyond the purpose of citation (see Chapter 1.2).

# 3.6.2 When may I cite an image in my work?

You may use pictures according to the right of citation (Zitatrecht, see Chapter 1.2). Note, that all transformations or alterations to the works may be done only with the permission of the copyright holder (§ 23 German Copyright Act). This includes image fragments, translations, and additions.

Example 1: For your dissertation, you use a published image of an experimental setup that you need as a basis for further experiments described in your work. You discuss the image thoroughly. You cite the source correctly.

Let's check the usage by applying the **PEMUC** scheme:

**P**urpose of citation: Experimental design that forms the basis of further investigation (= purpose of citation is given).

Explanation: The picture is explained in detail.

**M**inimum: Since you are not allowed to change the image, you may and must quote the complete image. Since the image is necessary for the description of your procedure, this requirement is also fulfilled.

**U**nchanged: You have not changed the image.

Credit: You have indicated the source with a brief reference in the caption. The complete source is mentioned in the reference list.

Conclusion: The image citation is permitted.

Example 2: For your dissertation, you use a photograph from a historical picture. The picture is not necessary for your argumentation but merely for illustration. The photographer died more than 70 years ago. You cite the source correctly.



Purpose of citation: Not given

**Explanation**: No explanation, only used for illustrations.

**Minimum:** You use the entire image.

**Unchanged**: You have not changed the image.

**Credit**: You have indicated the source with a short reference in the caption. The complete source is mentioned in the bibliography.

Conclusion: You may not use this picture within the scope of the right of citation. But since the author has been dead for more than 70 years, the picture is no longer protected by copyright. It is now in the public domain and may be used. As always in a scientific context, you name the source.

#### What do I do if ...

#### 1 ... the image I want to cite has not yet been published?

→ Ask the author if you are allowed to cite their image and reference the image as an unpublished work with a corresponding reference in the reference list (see Chapter 3.18). In rare cases, you publish the image in the place and name of the author. In this case, there is no reference in the reference list. Instead, you refer to the author in a note, e.g. with a phrase like "Printed with the kind permission of [name of author].

#### 2 ... the image was published in a journal?

→ Cite it like any other source. If you meet the requirements of the citation right, you do not need special permission from the publisher - even if the publisher offers permission.

### 3 ... I do not explain the image in the text?

- → If your picture is neither in the public domain nor published under a matching license, please ask the copyright holder for permission. The rights holder can be the author, but also a publisher who has acquired the sole (exclusive) rights of use from the author.
- **4 ... I want to change the image** (e.g. use a section, translate, add details, omit details, change the display)?
- → Ask the copyright holder for permission or create your own image. More about this in Chapter 3.6.4

#### 5 ... the image comes from a standard?

→ An image in a standard may replace the entire standard. If you use this image in your own work, this can damage the economic exploitability of the standard. For this reason, be particularly careful when using images from standards. For more information, see Chapter 3.16.



# 3.6.3 Permissions for the use of images beyond the right of citation

If an image is not citable under copyright law, you can cite it if you have the consent of the copyright holder to use an image. This consent may be given orally. However, if you want to be on the safe side, you might want to ask for written consent. To do so, it is important to be sure you actually know who owns the copyright. The exploitation rights to an image can also be transferred to a publisher, for example, if the author of the image has already published it and signed a corresponding contract.

Balzert et al. (2013, p. 190) provide an important source for obtaining image rights: <u>VG Bild-Kunst</u>. This collecting society (i.e. VG Wort) issues printing permissions for most living artists and photographers. However, in many cases, the images you want to use, will not be from artists or photographers. In these cases, please contact the author or the publisher directly to obtain the necessary rights.

**Creative Commons** licenses offer another form of written consent for the use of images. These licenses allow the copyright owner to offer the public expanded exploitation rights. Creative Commons licenses thus always extend the provisions of copyright law. For more information, see Section 4.1 below.

# 3.6.4 May I change an image?

If you cite images, you always cite the entire work and thus quote directly. Which means you may not change the work. If you still want to change the image, you have two possibilities:

- 1. get permission from the copyright holder, or
- 2. cite indirectly (paraphrase).

When you cite an image indirectly, you take the idea and create your own image - giving the idea a new appearance. As with all indirect citations, you specify the source on which your image is based. The in-text citation in the caption should indicate whether it is the original image or whether the original just served as the basis for your own illustration. You can indicate this by using an introductory phrase like:

- Based on ... / Inspired by ...
- Adapted from ... / Modified from ...

# 3.6.5 What else do I have to consider when using (my own) photos?

## Copyright on depicted motifs

When using images, you also need to respect the **copyright of the depicted subject**. This is in addition to the copyright of the author of the image itself, for example, in works of art or if buildings are depicted.



**Architectural and artistic works** are protected by copyright. You, therefore, need the consent of the architect and the artist, even if you have taken the photograph yourself. This copyright protection expires 70 years after the creator's death.

There is an exception to this rule: You are permitted to make use of the so-called "Panoramafreiheit" (freedom of panorama). You may publish photographs of the exterior of a building without special permission if it is located on a public street or a public place permanently 59 German Copyright Act). The freedom of panorama also includes works of art when they are situated in a public area. The reproduction (photo or video) must, however, be made from a publicly accessible place. A picture that is e.g. taken from the window of a building across the street does not qualify as publicly accessible. If the building is not in a publicly accessible area, or the picture is of the building's interior, the consent of the architect must be obtained.

## **Domiciliary rights**

When recording within buildings and real estate, e.g. stations, stadiums, or private houses, domiciliary rights must be observed. Unauthorized pictures constitute a violation of general personal rights. Again, therefore, the consent of the holder must be obtained before publishing.

### Right to your own image / personal rights of depicted persons

If people are visible in a photograph, you also have to be careful: only with the consent of the persons depicted, may such images be circulated. This also applies to X-ray images<sup>12</sup>. You will find the relevant provisions in § 22 KUG (Law on Copyright in Works of Fine Art and Photography). Exceptions to the law include persons recorded as an "incidental addition to a landscape", public figures, or persons that are recorded as part of a gathering, etc. (§ 23 KUG).

# 3.6.6 Special case: Screenshots

Screenshots can be a useful way of supporting your text. Whether you are allowed to cite screenshots depends on what is shown. The key distinction here is whether the content is protected by copyright law or not; the rules from Chapter 3.6.5 apply. This chapter summarizes the content of (Steinhau, 2020).

The condition for citing a screenshot is that the screenshot shows a legal and published source and that you provide a full reference – as for all images.

#### What does the screenshot show?

#### User interfaces

Small symbols and icons are usually not protected. Screenshots of user interfaces that show navigation panels or functional elements can therefore usually be cited.

Photographs, images, videos, works of art, computer games, or multi-media applications

Use permitted as per citation law (see Chapter 1.2) or with permission of the rights holder.

• Illustrations, Infographics, etc.

Use permitted as per citation law (see Chapter 1.2) or with permission of the rights holder.

Maps

See Chapter 3.10

Text (+image) content from newspapers, journals, websites, and e-books

Use permitted as per citation law (see Chapter 1.2) or with permission of the rights holder.

Logos, trademarks, and composite marks

Use permitted as per citation law (see Chapter 1.2) or with permission of the rights holder.

Important: The impression should not be created that the company the logo represents, has contributed to the cited work. The logo should also not be used for commercial purposes without permission.

#### People

Use only with the copyright holder's permission. This also applies to webinars, video conferences, and video chats.

Free licensed works / open content (e.g. Creative Commons)

Use permitted as per citation law (see Chapter 1.2) or via the license granted. If the work is used beyond the right of citation, the license conditions must be complied with. These often specify how the source and license information should be indicated.

If a screenshot contains individual elements of which you are not sure whether they are protected by copyright law, and the use is not covered by citation right, you can conceal this content (pixelate, blur, black out, or remove).



# 3.6.7 Captions and list of figures

Images (your own or other people's) should be numbered and titled in your work (number and title, for images above, for tables below). All images should be listed in a separate table of figures.

If images, etc. are taken from other works, you must, in addition to numbering and titles, specify the source from which you took them. The citation is done in the form used elsewhere in the work, e.g. in a footnote, or in short form directly after the title.

Charts are treated as figures and as such are listed in the list of figures. Information on the design of charts according to TUM corporate design guidelines can be found here: https://portal.mytum.de/corporatedesign/index\_html/regeln/index\_diagramme (page only available in German).

Example of an image with the source cited in the references:

The work referred to in the citation must be listed in the reference list.

The table of figures is located at the beginning or end of the work (but before the references) and lists all images in numerical order. The sources of the images (books, webpages, etc.) appear in the full list of references.

#### Images from the internet (with and without license)

[Author's last name], [Author's first name abbreviated]. [(Publication year)]. [Title of the image if available, otherwise short description of the image in square brackets]. [Type of image]. [Title of website]. [URL]. [License]

If the image has no title, add a short description of the image in the bracket with the image type. This can look like this, for example:

Rinaldi, J. (2016). [Photograph series of a boy who finds his footing after abuse by those he trusted]. The Pulitzer Prizes. https://www.pulitzer.org/winners/jessica-ninaldi

If the image was published under a creative commons license or a comparable license, add the following information before the URL:

#### [Name of license including a link to the license text].

If your work is a printed work, write out the link to the license text.

Here are two examples of images from the internet with a license:

Please note that pictures sourced from image databases like Fotolia, Shutterstock, or Pixelio have to be referenced as defined in the terms of use by the image database's agency.<sup>13</sup>

#### 3.7 Interview

**Interviews, which can be found printed in a magazine**, for example, are citable and appear in the reference list. Harvey (2008, p. 69) provides the following example (formatted in CMS Style):

3. Candace Caldwell, "Lust of the Eye," interview by Malcolm Strong, *Visual Arts*, June 1995, 23-29.

The APA Publication Manual also provides examples of how interviews are cited. Interviews can be published in newspapers, magazines, radio shows, podcasts, television shows, etc. Cite the interview in each case like the publishing source.

#### Interview printed in a newspaper

If the name of the person interviewed is not mentioned in the reference, include it in the title. For interviews that are recorded and preserved in a digital or physical archive, credit the interviewee as the author.

**Interviews that you have conducted yourself**, should be marked accordingly in the text. Kamasin and Ribing (2011, p. 150) recommend specifying the following data:

- Academic title of the interviewee
- First name and last name
- Function in company (in the organization, at the institution)
- Company, institution address (no private address!)
- Exact date and time

A self-conducted interview may be added to the appendix of your work. Obtain consent from your interviewee before you use any part of the interview and the form in which you wish to use it.

# 3.9 Laws

Laws are not protected by copyright (§ 5 UrhG<sup>15</sup>) and can therefore be cited without issue. At the first mention of a law in a text, its complete title is mentioned; once an abbreviation is established, it is used in subsequent mentions (example: § 51 Gesetz über Urheberrecht und verwandte Schutzrechte (Urheberrechtsgesetz), thereafter, § 51 UrhG).

The rules of good scientific practice require that the sources which are referenced are marked as precisely as possible. The examples of citations <u>from legal texts</u> given in the APA style manual are tailored to American legal texts. We, therefore, recommend that you use the same citation style as Brink (2013, p. 224 Fig. 7.2) for the short in-text citation:

Some laws have articles instead of paragraphs, e.g. the German Grundgesetz (GG) and all Bavarian laws (e.g. the Bavarian Higher Education Act). One then writes e.g. Art. 1 Abs. 1 GG.

The abbreviations used for short in-text citations should always be included in the list of abbreviations.

Whether or not you also include the laws from which you cite in your references depends on the conventions of your subject. Please follow the recommendation of your supervisor. If you do choose to include an entry in the references, the official publication of a law should always be indicated there.

#### **Examples of legal references in the references:**

Urheberrechtsgesetz vom 9. September 1965 (BGBI. I S. 1273), das zuletzt durch Artikel 1 des Gesetzes vom 20. Dezember 2016 (BGBI. I S. 3037) geändert worden ist. 18

You can also find detailed information on citing laws and regulations of all kinds in the Handbuch der Rechtsförmlichkeit by the Bundesministerium der Justiz und für Verbraucherschutz (Part B, Chapter 3) <sup>20</sup>.

For judgements and decisions, Brink (2013, Fig. 7.3) recommends the following model:

Judgements and rulings are usually not listed in the references but in a separate reference list. The information there corresponds to the references in the text.

#### Notice:

Commentaries are very often loose-leaf collections that are continually updated. It is therefore very important that you indicate in your bibliography exactly the status of the commentary to which you refer.

# 3.10 Maps

Maps are subject to copyright protection law and must therefore be cited. While survey data – roads and the like – are free facts, the layout of the map or the particular composition of the data may be protected by copyright.

There is no indication in the legal practice as to whether modifications, such as cropping and marking, are permitted or whether maps, like images, may only be cited unchanged.

Especially for online maps, where often only a part of the map is visible on the screen, it is advisable to use maps that explicitly allow modifications. This is the case with Open-StreetMaps, Google Maps and Google Earth. Please follow the providers' license terms, both with regard to the required source and license information, as well as with regard to the changes that are permitted.

Another possibility is simply drawing the map yourself. This is the best way to highlight the information that is relevant to your work. Name the data source on which your map is based.

#### **OpenStreetMaps**

OpenStreetMaps is a free project, whose maps is licensed through the OpenData Commons Open Database License (ODbL). The map representations are often under a CC-BY-SA license. However, since the maps are created by different people, the license may vary. Therefore, always check which uses the respective license allows. As a rule, use and adaptation are permitted if the source is specified and the new work is licensed under the same conditions. Link the license to the license text or, in the case of printed works, provide the link to the license text. Information about the license is always found below the map on the right.

OpenStreetMaps also offers the possibility of creating a permalink for a displayed map excerpt (for permalinks see Chapter 3.18, Web pages). You should always specify this permalink in the source to facilitate retrieval.

If you use a lot of maps in your work, create a list of all the maps in your work - analogous to the list of figures or tables.

In general, the schema for electronic maps looks like this:

For dynamically-generated maps, specify the retrieval date. If the map has no title, give a short description of the title in square brackets.

Google. (n.d.). [Google Maps directions for driving from La Paz, Bolivia, to Lima, Peru]. Retrieved February 16, 2020, from <a href="https://goo.gl/YYE3GR">https://goo.gl/YYE3GR</a>

Except for the above-mentioned examples of electronic maps, the APA style does not provide any other examples of maps.

Printed maps should be described as accurately as possible. If possible, mention the following information in the reference:

Author, title, edition, scale, place of publication, publisher, year, material description (map, relief, architectural drawing), other physical characteristics (on parchment, digital, etc.), size, information on a series the map belongs to.



In addition, you can differentiate between the individually published maps, and maps from atlases (Northey & Knight, 2007, pp. 234-235):

## Individually published map

Zania. Population over 50 [demographic map]. Zunila: Census Division, Office of International Affairs; 1995 Scale 1: 1,500,000. 2 sheets.

## Map from an atlas

Chatham Islands. Fluvial features [topographic map]. In: Atlas of islands. San Francisco: Floating Press; 2001 p. 44-5. Color, scale 1: 250,000.

# 3.11 Newspaper articles

[Author last name], [Author first name(s) abbreviated]. [(Year of publication, Month in words Day)]. [Title of article]. [Name of newspaper]. [URL]

Guarino, B. (2017, December 4). How will humanity react to alien life? Psychologists have some predictions. *The Washington Post*. https://www.washingtonpost.com/news/speaking-of-science/wp/2017/12/04/how-will-humanity-react-to-alien-life-psychologists-have-some-predictions

Occasionally you will find newspaper articles with references like this:

E.g.: ZEIT ONLINE, AFP, dpa, hgö (Gökkaya, 2019)

dpa and AFP stand for the news agencies Deutsche Presseagentur and Agence France-Presse<sup>22</sup>. Hgö is linked to the authors' profile of Hasan Gökkaya. In our reference list we only mention the author:

Sometimes it happens that the author's initials do not have a link to a corresponding author's profile. In these cases, it is worth enquiring at the newspaper's archive. If there is no linked author's profile, omit the author in the reference list entry and place the title in the first position. If the author's initials in the above-mentioned article did not link to an author's profile, then the reference in the bibliography would look like this:

## 3.12 Patents

For in-text citations, give the patent number and the issuing date. U.S. Patent No. 123,445 (1988) or (U.S. Patent No. 123.445 1988)

In the reference list, you include the inventor's name and the official office where the patent can be seen.

[Inventor's last name], [Inventor's first name abbreviated]. [(Issue date)] [Title of the patent]. [Patent number]. [Patent office]. [URL]

Hiremath, S. C., Kumar, S., Lu, F., & Salehi, A. (2016). *Using metaphors to present concepts across different intellectual domains* (U.S. Patent No. 9,367,592). U.S. Patent and Trademark Office. http://patft.uspto.gov/netacgi/nph-Parser?patentnumber=9367592

Usually, there is one patent office in every country. This means that the abbreviation U.S. stands for the U.S. Patent and Trademark Office in Washington DC. The abbreviation DE stands for the German Patent and Trademark Office (Deutsches Patent- und Markenamt) in Munich.

Other citations styles might also mention:

- The name of the assignee or applicant. (Patents are often registered by companies.)
- The registration date (sometimes it might be the approval date or the publication date, so best name which date you use.)
- The URL to the patent's full text.

Patents often have a version number like A1, A2, ... or B1, B2, ... This has to be given in the reference, too.

Example: DE 27 03 353 A1

DE 10 2005 051 128 B4

# 3.13 Personal communication and expert opinion

For unpublished information, which has been given to you by an expert in a personal conversation or via email, APA style lists the following information:

[Author last name], [Author first name(s) abbreviated] [(personal communication, [Month in words] [Day], [Year])]

#### Example:

T.K. Lutes (personal communication, April 18, 2001)

Since the reader cannot view personal information, according to the APA style, they are listed in the text only, not in the reference list.



In other citation styles, you can often find the following information:

- Full name
- Qualification / position and workplace / institution
- Place of work / institution (without postal address or email address)
- Date and time incl. time zone
- Title of presentation / subject
- Type of communication / source with addressee

#### Example:

Braun, Gary P. (Prof. for Accounting, College of Business Administration, University of Texas at El Paso) (02.08.2000, 10:18 RDT): "Re: Questions about Accounting Terminology". Email to Bruce W. Irwin

Womser-Hacker, Christa (Prof. für Angewandte Informationswissenschaft, Institut für Angewandte Sprachwissenschaft, Universität Hildesheim) (01.08.2000, 9:18-9:25 MEZ): Personal communication with Bruce W. Irwin

Such a reference would then be placed in the footnote.

## 3.14 Research data

Research data forms an important basis for academic knowledge. To derive the greatest possible benefit from the data collected, research data (primary data and secondary data) is increasingly published in its own right. This allows researchers with different research focuses to use and cite the data. If data cannot be published or is subject to an embargo period, the reasons for this should be made clear.

So where can you find research data? How do you cite it? And how do you publish it?

## Finding research data

Often research data is published in repositories. The TUM repository is called <u>mediaTUM</u>. Subject-specific repositories are listed by <u>re3data</u>.

#### Citing research data

A research data reference should include the following:

- Author
- Publication date
- Title
- Version (if applicable)
- Publication agent (Institution)
- Type of resource
- Identifier (if applicable)



Research data can be especially well cited if there is already a persistent identifier like a DOI registered.

## Example:

If the record does not have a version number, omit this information.

#### Access-restricted research data

Some research data cannot be published immediately or even not at all. For data protected under EU data protection law or data included in patent application processes, access may be restricted or prohibited. In these cases, however, at least the metadata that provides information about access conditions should be published – keyword: FAIR principles (GO FAIR,



2022; Wilkinson et al., 2016). As an example of how to specify access conditions for research data with restricted access see Stelzle et al. (2020):




Figure 4: Metadata for research data on mediaTUM (Stelzle et al., 2020)

If you want to cite research data without published metadata specify [Unpublished raw data] as the source type. Instead of the year of publication, enter the year(s) of collection. If the dataset does not have a title, provide a brief description in square brackets. This may look like this:



Bear, R.A. (2015). [Unpublished raw data on the correlations between the Five Facet Mindfulness Questionnaire and the Kentucky Inventory of Mindfulness Skills]. University of Kentucky.

Remember that you always need permission from the copyright holder if you want to use unpublished sources. For further information on unpublished sources see Chapter 3.19.

#### Publishing research data

You can publish your research data either on the TUM repository mediaTUM or on a subject-specific repository.

You can find out how to publish your data on mediaTUM here.

To provide your data with a permanent identifier, you can apply for a DOI. Our team will be happy to support you with courses and advice on research data management.

Helpful information on how to publish research data under open licenses can be found in the guide "Rechtsfragen bei Open Science" (Kreutzer & Lahmann, 2019).

# 3.15 Software and apps

If you use specialized software for your work, it must be cited. Standard software such as Microsoft Word or Excel, Java, Adobe Photoshop, SAS, SPSS, etc. need not be cited. If you use standard software to collect, evaluate or present results in a special way, please state the name and version of the software in the text.

Example: Data was analyzed with IBM SPSS Statistics (Version 25).

For specialized software, refer to it in the reference list according to the following scheme:

#### **Software**

[Author last name], [Author first name abbreviated]. [(Year)]. [Name of software] [(Version number)] [[Computer software/Mobile app]]. [Name of publisher or app store]. [URL]

Borenstein, M., Hedges, L., Higgings, J., & Rothstein, H. (2014). *Comprehensive metaanalysis* (Version 3.3.070) [Computer software]. Biostat. https://www.meta-analysis.com

If there is no author, specify the publisher as the author instead and omit the indication of the publisher before the URL.

TechSmith Corporation. (2020). *Camtasia Studio* (Version 2019.0.108.6.0) [Computer software]. Okemos, MI: TechSmith Corporation. https://www.techsmith.de/camtasia.html

These schemes come from the APA style. Other styles also name the publication date or access date. In addition to the term "computer software", the terms "software" or "program" are also very common.



## **Apps**

Apps follow the scheme for software. Here is an example:

## 3.16 Standards

Standards are usually protected by copyright and can be cited under the right of citation according to § 51 UrhG. However, just as with other protected works, you should take care to use the cited work to an extent that does not violate the interests of the author. This means that the citation must not be so extensive that it could replace the cited work or that a user would no longer buy the original work (Lüft, 2019§ 51, Rn 6-7). You should be particularly careful with images from standards. It is often difficult to decide whether this is a permitted act of use under the right of citation or an infringement of the author's right of exploitation. Therefore, in case of doubt, you should always ask the Beuth-Verlag. You can obtain permission there as well.

#### Permission form: here

The Beuth-Verlag's recommends to cite standards like this:

Example: DIN ISO 8037-1:2003-05, Optik und optische Instrumente - Mikroskope; Objekt-träger - Teil 1: Maße, optische Eigenschaften und Kennzeichnung (ISO 8037-1:1986)

However, you should always adapt the editors' citation suggestions to the guidelines of your citation style. In the APA style, there are no specifications for citing standards. If we try to follow the general APA scheme a source citation for standards could look like this:

Deutsches Institut für Normung (2003 May). *DIN ISO 8037-1: Optik und optische Instrumente – Mikroskope; Objektträger – Teil 1: Maße, optische Eigenschaften und Kennzeichnung (ISO 8037-1:1986*).

In the IEEE Editorial Style Manual you will find the following (IEEE Publishing Operations, 2020, p. 17):

#### Basic format:

[1] Title of standard, standard number, date.

#### Examples:

- [1] IEEE Criteria for Class IE Electric Systems, IEEE Standard 308, 1969
- [2] Letter Symbols for Quantities, ANSI Standard Y10.5-1968.



# 3.17 Students' projects

Students' works have to be cited. Even if you supervise student assignments, for example, as part of your Master's thesis or your dissertation, and have thus contributed to the creation of the work, it remains the case that copyright belongs to the author.

Should you want to cite from an unpublished student's work, you have to seek the student's (=author's) permission (TUM Graduate School, Fakultäts-Graduiertenzentrum Maschinenwesen, 2012) and document this in your thesis together with the citation. Follow the scheme for unpublished university publications (s. Chapter. 3.4).

However, it is easier if the student's work has been published. TUM advises publishing final papers if significant scientific results were obtained.

There are different ways to publish:

- Online publication on the media server mediaTUM: if you want to publish a student examination paper on mediaTUM, please send an email to the address support.diss@ub.tum.de or upload the paper yourself using your chair's mediaTUM account. Our mediaTUM team will be happy to answer any further questions regarding mediaTUM via mediatum@ub.tum.de.
- Making your thesis available at the university library: <u>further information on how to publish students</u>' theses via the library.
- Another alternative would be to publish a technical paper together with the student, based on the student's work (i.e. within a publication series at your chair), and to cite this technical paper.

## 3.18 Tables

Copyright law does not protect quantitative data. Therefore, you can always cite them. You can even use extracts from tables in your own table if you mention the source. If you create a table using data from different sources, you have to make clear, where the information comes from. However, make sure that this extract does not misrepresent the data or present it in a misleading context.

In contrast to the data itself, the display of the data may be protected. If a program like Excel generates the display, the level of creativity necessary for gaining copyright protection, will usually not be attained.

Just as with images, tables should be numbered. All tables are listed in a separate list of tables, with the table number, table title, and page number.

In contrast to images, **table titles usually appear above** (**image titles appear below**). When you use a table from a work, you reference it in the text next to the page number, including the original table number. The work appears in the reference list.

#### Data from different sources

If you have collected data from different sources in one table, the source of information in a cell has to be clearly visible to your reader. To show that data in a row or column comes from the same source, you can use various methods such as putting it in the table heading (blue), column/row heading (green), or adding an extra row/column (purple).

If you cannot specify the origin of the data line-by-line or row-by-row, or you have too many sources to list them all in the table heading, you might want to give the exact origin of all data in the appendix, where you can give the origin for each cell individually. In the table heading, you could refer to your sources in the following way:

# 3.19 Unpublished Sources

Unpublished sources should only be cited if the information is not otherwise available to the reader. In general, unpublished sources are cited in the same way as published ones.

Unpublished sources may only be cited with the author's permission. This is not necessary if the copyright has already expired. If possible, include the source in the appendix to make it accessible to your reader. Keep in mind that permission to cite a work does not automatically mean permission to include an unpublished source in the appendix. Make sure to get this additional permission. The work is not listed in the reference list unless it is available in an archive. In this case, give the information on where to find the document in question at the end of the reference and include it in the reference list.

The entry in the reference lists includes the following information:

[Author last name], [Author first name abbreviated] [(Year)]. [Title of source]. [Unpublished manuscript/Manuscript submitted for publication/Manuscript in preparation], [Chair/Faculty/], [Name of institution].

The APA style specifies here that not the journal to which the manuscript was submitted is indicated, but the institution at which the article was written.

## 3.20 Videos

In general, videos are protected by copyright and may be cited within the limits of the right to citation (see Chapter 1.2). If you use an excerpt from a video in your academic work, you should describe what you want to show or paraphrase or transcribe the statement you want to use. Give the reference in the text in the same way as for written sources. In the same way, as you give a page reference, for a video you enter the time parameters of the video excerpt you use, e.g. (Schneider, 2018, min. 6:30-7:25). The reference in the reference list then looks like this:

Reference management programs usually only offer one document type for movies. Check whether the reference contains all the necessary information. In some cases, another document type may better represent a video from the Internet (e.g. web page).

If you want to use excerpts from videos in class, § 60a UrhG applies.

# 3.21 Web pages

Consider, that not all internet sources are web pages. Please check first whether your source is indeed a web page or rather a report, a journal article, a blog post, or any other type of source that has only been made available on a web page.

[Author last name], [Author first name(s) abbreviated]. [(Year, month in words day)]. [Title of work]. [Site name]. [URL]

If no authors are named on the website, the name of the website or the publishing institution takes the place of the author. The name of the website is then not repeated before the URL.

If you cannot find a date on the website, enter a retrieval date before the URL instead, following this scheme: [Retrieved Month in words day, year, from URL].

U.S. Census Bureau. (n.d.). *US. and world population clock*. U.S. Department of Commerce. Retrieved July 3, 2019, from <a href="https://www.census.gov/popclock/">https://www.census.gov/popclock/</a>

In general, we would recommend that all citations from dynamic web pages (e.g. blogs, forums, web pages from institutions, etc.) also include the access date.

For online sources, many citation styles indicate what type of source it is. For web pages, indications such as [Webpage], [Website], or [Online] are common. The APA style makes no such indication for web pages here.



When giving the URL always give the URL of the specific page you cite, not the general start page of the web page. Consequently, if you cite several subpages of a website, you include each subpage as a separate source in the reference list.

Make sure your **Internet sources** are permanently available wherever possible. If available, instead of a URL use a persistent identifier, i.e. a permanently available link (<u>DOI</u>, <u>URN</u>, <u>handle</u>, ...). These so-called **permalinks** (permanent links) work even when the post on the blog or wiki has been updated or changed. To be on the safe side, save web pages or print a copy so that you can submit them if in doubt. Some reference management software already offers a function to save screenshots of web pages (e.g. Citavi, Mendeley, Zotero).



# 4. Further questions regarding citation

# 4.1 How can I find free images? (Creative Commons)

Pre-licensing contracts made by the non-profit organization Creative Commons should help to define the rights and conditions for your own productions. CC licenses always enable the extension of the valid copyright to any further possibilities for use, they never pose an additional limitation.

From the user's perspective, CC licenses help to find content such as images or videos on the Internet freely available for use. Conversely, the absence of a CC-labeling, however, does not mean that the use of e.g. an image is not permitted. You should in this case carefully check the copyright provisions (see 1.4.3).

CC licenses remain valid as long as the copyright for the respective work is valid. Afterward works licensed by CC are in the public domain, too.

The following six licenses are currently available<sup>23</sup>:

## Attribution (by):

"You are free to:

Share — copy and redistribute the material in any medium or format

Adapt — remix, transform, and build upon the material for any purpose, even commercially." (Creative Commons, 2017f)

#### Attribution – No derivatives (by-nd):

"You are free to:

Share — copy and redistribute the material in any medium or format for any purpose, even commercially." (Creative Commons, 2017a)

## **Attribution – Non-commercial (by-nc):**

"You are free to:

Share — copy and redistribute the material in any medium or format

Adapt — remix, transform, and build upon the material" (Creative Commons, 2017d)

Beyond these you might find two other symbols:

## **Public Domain Dedication (CC0 1.0 Universal)**

"The person who associated a work with this deed has dedicated the work to the public domain by waiving all of his or her rights to the work worldwide under copyright law, including all related and neighboring rights, to the extent allowed by law.

You can copy, modify, distribute and perform the work, even for commercial purposes, all without asking permission. " (Creative Commons, 2017g)

#### **Public Domain Mark 1.0**

This work has been identified as being free of known restrictions under copyright law, including all related and neighboring rights.

You can copy, modify, distribute and perform the work, even for commercial purposes, all without asking permission." (Creative Commons, 2017h)

The license terms require that every time you use an item, the name of the copyright holder must be cited. You must also specify a link to the license and specify whether you have modified the item. A CC license does not relieve you of the obligation to cite! The license does ensure that the media found may be used.




Figure 5: Compatibility amongst Creative Commons Licences (Creative Commons, 2015 published under CC-BY 4.0 international licence https://creativecommons.org/licenses/by/4.0/legalcode)

Bear in mind that not all CC licenses can be combined. Figure 5 shows which CC licenses can be combined.

You can also specifically search for CC pictures. Certain search engines help find those. Some examples:

<u>Openverse</u> formerly CC-Search (): A Wordpress-connected search engine designed specifically to find CC-licensed works. Openverse searches platforms that offer CC-licensed content, such as Flickr, Wiki-media Commons, Stocksnap, or, for music, Freesound and Jamendo. A list of the platforms searched can be found here: https://wordpress.org/openverse/sources

Flickr: Use the Advanced Search to select a CC license for specific images you want to find.

<u>Google Image Search</u>: After entering a search term in the Google image search, you can filter results by license (menu item: Search Options  $\rightarrow$  rights).

<u>Let's CC</u>: As with CC Search, not a search engine, but an interface that uses a variety of other search engines to locate CC content.

**But be aware**: If you use an image that has been illegally posted on the net under a CC license - e.g. because a person falsely claims to be the author or has not obtained all the rights of other rights holders - its further use is also illegal. You may be held liable for unauthorized use, even if you knew nothing about it. In copyright law, there is no good faith protection. So, check the source of a CC-licensed material carefully before you use it.



# 4.2 How should I use images in my presentation?

As in your written work, you may also use images in presentations - as long as you comply with the requirements of the right to citation (see Chapter 1.2). If, for example, you use an image in your presentation, giving the full reference and explaining the purpose of the citation in your presentation orally, it is permitted by copyright law. The situation is different if you then share or distribute this presentation. In the presentation, the purpose of citing is not explained. This explanation must be included in a presentation if it is passed on to others. Hidden slides may be used, hiding the explanation during the presentation and displaying it for later distribution.

There is no set way to mark your sources in a presentation. The following solutions are possible:

- You name the complete source next to the picture on the respective slide.
- You use a short reference in the caption and mention the complete source in a reference list at the end of the presentation, as you would do in your academic work.
- At the end of the presentation, you list all sources and name the slide on which you used the image. If you have used several images on one slide, name an additional distinguishing feature (e.g., bottom left, top right, etc.).

A clear link between the image and its source is essential in presentations as well.

## 4.3 Who is the author? Who is the co-author?

There are several guidelines and codes of honor governing the proper approach to the subject co-authorship. The "Guidelines for Safeguarding Good Research Practice. Code of Conduct" have therefore been adopted at TUM. You will find the following regulations in § 12:

- "(1) An author is someone who has made a genuine, recognizable contribution to the content of a scientific text, dataset, or software publication, i.e., who has contributed to
- 1. defining the problem, drawing up the research plan, collecting the data, evaluating or interpreting research outcomes, or
- 2. ¹the draft or critical review and revision of manuscript content. ²Co-authorship does not apply to persons who merely made a technical contribution to the collection of data, merely provided funding, or merely served as the head of the department or institution in which the research was carried out. ³The same applies to persons who merely read the manuscript without contributing to its content. ⁴Honorary authorships are prohibited."

The American Physical Society recommends all other parties involved are mentioned in the **Acknowledgements** (*APS physics: Ethics and Values : 02.2 APS Guidelines for professional conduct.*, 2002).



More and more often, the individual contributions of different contributors are entered via the Contributor Roles Taxonomy (CRediT). CRediT distinguishes 14 roles, which often occur in scientific projects: Conceptualization, Data curation, Formal analysis, Funding acquisition, Investigation, Methodology, Project administration, Resources, Software, Supervision, Validation, Visualization, Writing – original draft and Writing – review & editing (CASRAI, 2018).

#### Here is an example:

AUTHOR CONTRIBUTIONS: S.C.P. and S.Y.W. conceived and performed experiments, wrote the manuscript, and secured funding. M.E., A.N.V., and N.A.V. performed experiments. M.E.V and C.K.B. provided reagents. A.B., N.L.W., and A.A.D. provided expertise and feedback. (Peterson et al., 2015)

Important note: Co-authors share responsibility for published papers. If you are listed as a co-author, you, therefore, have the right to check the final manuscript before submission. Exception: If you were involved in a specific, definable area, then you are only responsible for this part.

Depending on the field, the order of authors also has varying significance. So, it may be the case that the incumbent at the chair is named as the last author, while there are other fields where the author with the largest share of the publication is named first, etc. Sometimes the authors are simply arranged in alphabetical order.

#### Note:

The order of authors influences e.g. bibliometric analyses. Because often authors listed at the end are not included in the analyses. If you are unsure in which order to name the contributing authors, enquire about the usual practice in your field

Sometimes the order is established by drawing lots. Enquire about the usual approach in your field of research. However, when citing sources, you always keep the original order of the authors' names.

# 4.4 How do I cite myself? - Citation or second publication?

It is always assumed that scientific findings which appear without a citation

- 1. come from the author,
- 2. are new,
- 3. are published for the first time and
- are correct and complete (see U.S. Department of Health and Human Services, 2013)

It follows from points 2 and 3 that all content that you use and have published before must be cited. This is also emphasized by the DFG in its commentary on Guideline 13 of the Code "Guidelines for Safeguarding Good Scientific Practice" (DFG, 2022). Citing is therefore not only about protecting the intellectual property of others, but also about distinguishing between what is already known and new knowledge. Content should only be repeated if it is



necessary to understand the context. Self-citations as a means of inflating your h-index is considered unethical (TUM, 2021, p. 5, §11, para 5, no 1 sentence 3).

If you want to cite from your own works, the same rules apply as for citing from other authors' works (see Chapter 1.2).

Anything that goes beyond the boundaries of a citation must be regarded as a second publication. The right of second publication is regulated by § 38 UrhG.

Regardless of whether you are using an entire work or individual sections, the rules of good scientific practice require that it be made clear which part was taken and from where. A general mention in the preface may supplement but does not replace, the reference in the text.

However, today it is common practice that research results that are produced during doctoral studies are published in journals before the final dissertation is submitted. Since these results are an important part of the doctoral research, they are usually published again in the dissertation. The results are then not cited but published for the second time. Different rules apply for second publications than for citations. The right of second publication is regulated in § 38 of the Copyright Act (§ 38 UrhG).

Whether you are publishing an entire work or individual sections a second time, the rules of good scientific practice require that you indicate clearly which parts were published before and where. A general mention in the preface does not replace the in-text reference.

How can you use your own previously published work(s)?

## 1.) Citation

- Direct citation (=quote): For direct citations (i.e. the unchanged adoption), the same
  rules apply whether you cite yourself or someone else (see Chapter 1.2). This means
  that you must explicitly justify the use of the citation. To present results a second time
  is no longer a citation, but a second publication
- Indirect citation (=paraphrase): If you paraphrase, the copyright is not affected. As
  copyright law does not protect the idea, but the form of the idea. Properly paraphrased, you can cite as much as you like. However, to comply with the rules of good
  scientific practice, you must always give appropriate references.

#### 2.) Second publication

Adopting whole sections (no quotation): If you want to adopt whole sections, chapters, or the entire work without any changes, you must first clarify whether you have the right to use it. Firstly, it depends on which rights you have given to the publisher (this is stated in your author's contract), and secondly, whether you are the sole author. Even though you always remain the author of your work, you assign rights of use to the publisher. If you transfer too many rights to the publisher, you must ask the publisher for permission if you want to use your work elsewhere. If you are not the sole author, you also need the permission of your co-authors to republish parts or the whole article.



## Also important for second publications:

- Which version may you use? (in case of a second publication of a complete article) This may vary from publisher to publisher. Sometimes you may republish the submitted version, sometimes the final author manuscript before the publisher's layout, and sometimes the final version in the publisher's layout. You need to clarify which version you are permitted to use.
- Intended use for permissions: The purpose of use is also important for approvals. In some cases, a second publication in the dissertation will be permitted, but not in a work independent of the examination process. Always specify exactly which use is to be permitted when seeking approval.
- Reference to first publication: To do justice to the principle of transparency, you must also ensure that the distinction "new vs. already known" is clear as regards your previously published works. General introductory sentences such as "parts of this chapter / this work have already been published in xy" are not sufficient. The easiest way to make this distinction is to group previously published results together and then cite the original publication. The reference should be given the same way you cite any other source in your work. Present not yet published results separately. This way, the new vs. already-known distinction is preserved, and previously published results are visible as such.

Further explanations and recommendations on second publications for scientists can be found in Spielkamp (2015).

#### Self-plagiarism vs. text recycling

The term "self-plagiarism" is deliberately not used in this guide, as the term is a contradiction of itself. While plagiarism involves passing off someone else's work as one's own, it is hardly possible to pass off one's own earlier work as one's own unauthorized. In the case of plagiarism, readers are deceived as to the authorship of a text. Where self-plagiarism is mentioned, it is usually more a case of deception regarding the novelty of a text and the lack of rights of use. The German Research Ombudsman takes up the recommendation of the Text Recycling Research Project (TRRP) to replace the term self-plagiarism with the term text recycling (Hagenström, 2022).

The TRRP distinguishes four categories of text recycling (Hall et al., 2021b):

- 1. developmental recycling: publication based on previously unpublished texts (e.g. conference presentations or posters).
- 2. generative recycling: adoption of identical or almost identical passages in a paper with new original research results (e.g. background information or method descriptions).
- 3. adaptive publication: use of central parts or entire papers, often in a different text genre, in order to reach a different audience (e.g. articles in a dissertation or a book).
- 4. duplicate publication: use without (significant) changes, usually with infringement of copyright or publishing rights.



While the first category is considered uncritical, the transition is fluid for categories two and three, from uncritical to ethically questionable. Use under category four is considered unethical. (Hall et al., 2021b, pp. 2-6; Moskovitz, 2018). The TRRP also provides important guidance on the re-use of results and publications in its guidance for researchers (Hall et al., 2021b) and best practice recommendations (Hall et al., 2021a).

# 4.5 Is there an international copyright?

The principle of "Lex loci protectionis" applies to copyright law: the law of the country in which copyright protection is claimed, i.e., in which the work was published.

(JuraForum News, 05.09.2011)

Example: You publish a paper in the American journal "Cell". This is where you claim American copyright protection, your paper is subject to the "Copyright Law of the United States of America". If a copyright infringement of your work occurs in a text published in the UK, in litigation only UK copyright applies.

Tip: If you write yourself

If you write a paper yourself, always consider the internationally valid ethical rules of good academic practice. As far as the law of citation is concerned, the German legal system is rather strict, so if you stick to these regulations, you are on the safe side. If you publish in another country, however, you will have to comply with the copyright law that applies there.

You are therefore bound by the copyright law of the country in which you publish.

There are efforts to harmonize the copyright laws of individual countries, and international copyright agreements have been concluded. The first treaty under international law in this field is the Berne Convention for the Protection of Literary and Artistic Works, now the Revised Berne Convention (RBC) of 1886. Currently, 171 states have signed this agreement. Since there are 194 countries in the world, the treaty is of great importance. (Kreutzer)

There are also efforts at harmonization in the EU. Full harmonization has so far failed mainly because of the different legal traditions within the EU: the continental European "droit d'auteur" system (F, D) and the Anglo-American copyright system (GB, IRL) (see Table 1). In the continental European copyright system, the rights of the author, which is exclusively the creator of the work, are protected. In the Anglo-American copyright system, users are protected, which means rights holders do not have to be the creator of the work. (Ohly, 2016, p. 10)

## Fair use principle in comparison with German citation law

The fair use principle in US law is difficult to grasp, so in the US, copyright issues can often only be settled by courts. The courts are guided by four factors:

- 1. the purpose and character of your use
- 2. the nature of the copyrighted work
- 3. the amount and substantiality of the portion taken, and
- 4. the effect of the use of the potential market.

(Stim, 2005-2016b)

## The copyright notice

The C in a circle, the American copyright notice, is now also found in publications in other countries than the USA (for example, in Germany). After the ©, the name of the copyright owner and the publication year are mentioned. This sign has no meaning in German copyright, and is not bound to any form; German copyright applies from the date of the creation of a work. (*Recht A - Z : Fachlexikon für Studium, Ausbildung und Beruf* 2015, p. 103) In the case of publications in the USA, the copyright notice is, however, no longer mandatory, but it is still recommended that you include it, for example, to improve your chances of winning in subsequent litigations. (Stim, 2005-2016a)

## 4.6 Can I cite retracted articles?

Sometimes publications are withdrawn due to qualitative or legal shortcomings. Then a so-called retraction note or retraction notice is published. It announces that an article has been withdrawn and what the reasons behind this are. In principle, retracted articles should not be cited. In exceptional cases, however, there may also be good reasons to cite a retracted article.

#### How do I find out if an article I want to cite has been retracted?

- 1. Search the database where you originally found the article. Search for the title of the article. Most databases mark the reference entry of the original article as "Retracted" but not all do. Also, the authors of the original article are not always mentioned in the record of the retraction note. If you only search for the author of the article, the retraction note may not be displayed. If you search with the title of the article, you will usually find both the original article and the retraction note.
- If the PDF file of the article contains a CrossMark button (see Figs. 4, 5), follow the link and you will immediately know whether it has been corrected or retracted.
- 3. Search the Retraction Watch Database at for the article.

There are several reasons why articles are retracted. Retraction Watch (2019) lists over 90 reasons, among them: Copyright claims, duplication of article or image, error in analysis, fake peer review, falsification / fabrication of data, lack of approval from author, manipulation of images or data, results not reproducible or salami slicing.

#### What do I do if an article I want to cite has been retracted?

- 1. Check if the information you want to cite has already been published elsewhere. If so, cite this source. If this is not the case ...
- 2. ... check why the article was retracted. Does this affect the reliability of the statement you want to cite?
  - a. If so, do not cite and do not use the information.
  - b. If the results of the article appear scientifically sound, check whether the full text can still be found. Some publishers link its retraction note instead of the retracted article. If the full text is no longer available (not even printed), do not cite the article.

If the reasons for the retraction do not compromise the quality of the content you want to cite, cite the article and disclose in a note that 1. the article was retracted, 2. why it was retracted, and 3. why you are citing it anyway.

Before you submit your work, you should check all sources again to see if any of them have been retracted.



## 4.7 How do I cite charts from Statista?

The reference information in Statista usually looks like this (s. There is a copyright notice below the figure, as well as a reference to the source of the data on the right side of the figure. Statista prepares third-party data graphically but does not usually collect the data itself.

Here we have a particularly complicated case because the source of the data is the BMVI, the Federal Ministry of Transport and Digital Infrastructure. However, the data was published in numbers in a Focus article. It remains to be assumed that the BMVI never published the data itself. The Focus received the data from the BMVI at its request and published it. Based on the data published there, Statista then created the chart shown above.

Which source you have to cite depends on whether you want to use the chart or the original data. If you want to use the original data, for example, to create your own chart or to include it in a table to compare it with other data, then check the original source, in this case, the Focus article, and cite the original source. If, on the other hand, you want to use the chart, you must disclose who the author of the chart is, but also where the data visualized in the chart came from.



The in-text citation in an author-year style could then look like this: (Illustration: Statista 2020, Data: Focus Online 2018).

In the references, list both sources separately:

# 4.8 What do I have to consider when using personal data??

You do not always cite other people's works. Especially when you collect data yourself or use your own images, you are often dealing with personal data. This can be, for example, in the form of interviews, patient data, X-rays, or people in images. In all these cases, it is important to take the General Data Protection Regulation (DS-GVO) into account. According to Art. 4 no. 1 of the DS-GVO, personal data are any information relating to an identified or identifiable natural person; an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

Without explicit permission from the people concerned, you may not publish such data.

Note that it makes a difference whether you only have permission to collect and store data for a study or the treatment of patients, or whether you are also allowed to publish it. Explicit consent must always be given for publication.

Every declaration of consent must inform the persons concerned in an easily understandable way about the purpose for which the data are collected, where and for how long they will be stored, by whom they will be used, and whom they can contact if they have questions or objections. In addition, the persons concerned must give their consent voluntarily and be informed that they can revoke it at any time without negative consequences.

If you have permission to publish personal data, always use it in such a way that no connection can be made to the person, i.e. the data must be anonymized, pseudonymized or encrypted.

The <u>eTIC</u> tool of the TUM Ethics Committee helps you to create correct patient information and consent forms.

## 4.9 Can I use an AI like ChatGPT to cite?

Legally, many questions about the use of generative AI such as ChatGPT have not yet been clarified. In principle, however, it can be said that what is permitted depends on what you want to use it for and in which situation. Do you want to cite the program as a source of information, use it as an aid to phrase your texts, or is the AI itself your subject of investigation?

#### As source of information

You cannot use ChatGPT or other AI programs as sources of information. The information may often be correct, but since the sentences are generated by probability, there is no guarantee that the information is correct. And even if it is, there is no way to trace where the information came from - making it unsuitable as a source of information for scientific purposes. Don't be fooled by AI-generated source citations. These are also generated by probability and often do not exist at all.(Salden, 2023, p. 9)

## To phrase texts

When it comes to phrasing texts, these programs can be very helpful. However, the question is whether they are allowed as aids for your current work and whether you adopt the Al-generated texts word-for-word or only use them as a basis for your own writing. For examinations and credits, you must adhere to the permitted aids and mark them accordingly. So first find out whether the program is allowed as an aid for your current work and if so, what kind of use is allowed.

Even though Al-generated texts do not enjoy copyright protection, you must always identify the source for sections of text that are taken over unchanged to ensure good scientific practice. Otherwise, you would pass them off as your own work. In terms of examination law, this would be considered an attempt to cheat. If, on the other hand, you only use the Al-generated text as an idea and rework it so thoroughly that it becomes your own work, this is acceptable for scientific use, provided that this type of tool is permitted for your work. If use is permitted in your case, you would list the program in your paper, just like any other aid. (Salden, 2023, pp. 23, 25-26) Make sure that you comply not only with the legal requirements but also with the terms of use of the software used. See Chapter 3.15 on how to cite it as a source.

As a rule, you should only use this type of program where you can assess the quality of the results.

#### As the subject of investigation

If, on the other hand, the program is your subject of investigation, its use is uncritical. However, Al-generated texts must of course be clearly identified as such here as well.

A good overview on the use of AI in the university context can be found in Fleischmann (2023)



# 5. Reference management software? – Yes! – But which one?

With reference management software, you can automatically cite correctly in the style of your choice. Reference management software helps to:

- Collect and organize references and files, cite correctly, and create a reference list in a predefined citation style
- Collect, organize and visualize thoughts and quotations
- Search for literature in library catalogs and databases
- Plan your tasks
- Work collaboratively with and connect to other scientists

Reference management programs are therefore definitely worthwhile for academic writing. There is a wide variety of programs on the market.

# 5.1 Reference management software: Which one is the right one for you?

Here you can find a detailed <u>comparison of reference management software</u>, including a list of questions that will help in choosing the right program.

The TUM University Library provides all TUM members free access to the software Citavi and EndNote as part of a campus license.

# 5.2TUM Campus license for Citavi

#### Citavi (Citavi website)

The site license allows you to use the program free of charge in the full version. Although Citavi is a system designed to run on Windows, version 5 will have a web version which will therefore be operating system independent. It is a widely used system at German universities with an intuitive graphical user interface in German, English, and five other languages. In addition to pure reference management, which also allows group use, further useful program features include knowledge organization and task planning.

#### 3 Steps to Citavi:

**Download & Installation:** First download the free version of <u>Citavi</u> and install it on your computer.

**Citavi Account:** To be able to use the full version and work with cloud projects, please register for a <u>Citavi Account</u> with your TUM e-mail address. Authentication with a freemailer address (e.g. web.de, GMX, Gmail) is not possible.

**Licenses Key**: Open Citavi and click on the login icon in the start window. Enter your access data for your Citavi account. The license information is now automatically recognized.



# 5.3 TUM Campus license for EndNote

EndNote (Link to EndNote Website) and

EndNote Web (Link to EndNote Web)

EndNote is available for the operating systems Mac OS X and Windows. It offers many options for data import, processing, and enrichment of references.

Endnote Web/Online can either be used as an online extension to EndNote or as a standalone tool. In this case, the functionality of Endnote online compared to the desktop version is somewhat limited.

Independently of the desktop version, we offer EndNote Web/Online via the license included in the subscription to the Web of Science database. You simply need to create an account. Since Endnote Web/Online is integrated as a feature in Web of Science, data import is very easy and convenient.

# 5.4 Free Programs

## Bibsonomy (Link to Bibsonomy)

Bibsonomy is a social bookmarking system. Users can store shared bookmarks and references on this online platform, and manage and develop content. By assigning keywords (tags), the collected data is structured and is easy to locate on tag clouds. Within the system, different people can join together to create special interest groups.

## Docear (Link to Docear)

Docear is an open-source reference management software with a special focus on the area of knowledge organization, e.g. the organization of knowledge in mind maps is possible. The free reference management software JabRef is integrated into the program, allowing optimal work with LaTeX. There is also a corresponding add-on for Word (Microsoft not Mac).

## JabRef (Link to JabRef)

JabRef is a free reference management software that can be used in conjunction with the document preparation program LaTeX. The program allows you to manage BibTeX files and edit with a comfortable user interface. The software is available for Mac OS X, Linux, and Windows.

#### Mendeley (<u>Link to Mendeley</u>)

The desktop version of the reference management software Mendeley is available for all major operating systems (Mac OS X, Linux, and Windows). In addition, there is a web-based service that, in addition to pure reference management, also includes a social network function. This facilitates group exchanges on academic topics and collaborations.

## Zotero (Link to Zotero)

Zotero was originally developed as an add-on for Mozilla Firefox. An additional stand-alone version is now available (for Mac OS X, Linux, and Windows). For use with Google Chrome



and Safari, there are so-called connectors. A special feature of the system is that you can store personal data collections in addition to the Zotero web pages (with automatic synchronization) and it is also possible to set up groups. This enables you to collect and edit references as part of a special interest group.

# 5.5 Reference management and LaTeX

The document preparation software LaTeX has a separate feature for reference management in BibTeX format. The reference management programs Docear, JabRef, and Mendeley provide very useful support in this format (including automatic import options for reference data). JabRef is an open-source program that is specifically designed to work with LaTeX. All three programs will store BibTeX files synchronically in the reference management database (i.e. with the data in **Mendeley**, **JabRef**, **or Docear**), even where there are subsequent changes. Docear, which is integrated into JabRef, also offers full support with reference management in BibTeX format.

All other reference management software also offers the option of generating and exporting BibTeX files. In case of subsequent changes to the data in the respective reference management software, the BibTeX file must be re-exported, however.

Unlike word processing programs such as Microsoft Word, a list of references is not generated by the LaTeX reference management program, but by BibLateX. Moreover, the citation style is not defined by the reference management software but is defined in the LaTeX document via the bibstyle.

Conclusion: Even when working with LaTeX, it is worth using reference management software.

If you have no specific requirements regarding citation styles, we recommend you choose one of the following three styles. These comprise an author-year style, a numbering style, and a footnote style. All three styles are widely used and are available in most of the reference management programs currently available (including Citavi and EndNote).
